February 27, 2017

Members Present: Doris Weisberg, David Bosted, Edward Sproles and Carmine Di Sanzo

Members Absent: Sheila Grant and Judy Bubar Others Present: Andrew Link, Staff Liaison

Andrew Link convened the meeting at 7:20 PM.

- Election of officers was held. Edward Sproles thanked Carmine Di Sanzo for his past service as Chair and nominated David Bosted for Chairman. Carmine DiSanzo seconded. There were no other nominations. Mr. Bosted was unanimously elected Chairman. Chairman Bosted nominated Edward Sproles for Vice-Chairman. Mr. Sproles declined as did Mr. Di Sanzo.
