**MEMBERS ABSENT: Chief Dan Posluszny, Lawrence Police Department; Carol Chamberlain, Health Officer; Allen Beard, Community Representative; John Gladwell, Community Representative and Jack Oakley, Emergency Management Coordinator.**

**Call to Order: The meeting was called to order by Chairman, Dale Robbins at 7:32pm.**

**MINUTES: The committee reviewed the regular monthly meeting minutes for March 10, 2009. A motion was made by Rich Krawczun and seconded by Chief Ray Nagy to approve the minutes as written. All were in favor.**

**OLD BUSINESS**

**HEALTH REPORT: Carol Chamberlain was not in attendance at the meeting, but Dale Robbins reported that there have been two (2) Bloodborne Pathogens Training sessions already held and one (1) more will be scheduled for those members who have not yet completed the required training. Rich Krawczun reminded the Chiefs that if members do not receive the required training, they will not be allowed to ride the apparatus.**

**EMERGENCY APPARATUS REPORTS:** All Slackwood and Lawrence Road apparatus are in service at this time. Ladder Tower 23 is currently out of service for a problem with the interface under the ladder. Once an estimate on the repair is accepted, the truck will remain out of service approximately 3 to 4 more weeks for the repair. Rich Krawczun reported that the Lawrence Township Emergency Services have one (1) ambulance out of service for rehabilitation at this time. They need to do a transition with the additional ambulance to the full time ambulance service. The specifications for the new ambulance listed in the 2009 budget are being completed at this time.

**PUBLIC SAFETY COMMITTEE NEWSPAPER ARTICLES:** Chief Posluszny was not in attendance at the meeting so there was no report.

**FIRE SERVICES STRATEGIC PLANNING COMMITTEE:** Chief Ray Nagy reported that they have not had a meeting but will be scheduling a meeting for some time next week. There was nothing to report at this time.

**FINANCIAL REPORTS:** Rich Krawczun has not received the financial report from the Lawrence Road Fire Company. Chief John Britton reported that John Fleming is the new treasurer and will see to it that reports are brought up to date.

**Wayside Lane to Route 206:** Due to the absence of Chief Posluszny, there was no further report.

**LIGHTED CROSSWALK at LAWRENCE ROAD AND LAWRENCE AVENUE:** Rich Krawczun reported that the township finally received the approval for the access permit. The township will need to meet with the owner of the property and then post bonds, develop the construction documents and put the project out to bid. It is hopeful that this will be completed by Fall, 2009.

There was no new business to be brought before the committee at this time.
