

## NOTICE OF BID

Township of Lawrence

Notice is hereby given that sealed bids will be received and publicly opened and read at the Lawrence Township Municipal Building, Lower Conference Room, 2207 Lawrenceville Road, Lawrence Township NJ 08648 at 10:00 a.m. prevailing time on April 28, 2016 for the project known as **2016 CONCRETE PROGRAM**.

The work under this contract consists of the selective removal and replacement of sidewalk, curb, and driveway aprons at various locations, 750 SY reinforced concrete apron replacement at Lawrenceville Fire House (Gordon Avenue) and Slackwood Fire House (Slack Avenue), 130 LF of PVC roof drainage pipe at Slackwood Fire House and other miscellaneous work as set forth in the specifications. Construction shall commence on or about June 1, 2016. Work at Community Center, Village Park and on Township roadways must be completed prior to beginning work at firehouses. Work at Fire House shall be completed by July 15, 2016.

Signed bids shall be submitted in a sealed envelope, addressed to the Engineering Department with the name of the project printed on the face of the envelope. Bids shall be rejected if not submitted within time, date and place designated, and if not accompanied by a certified check, cashier's check, or bid bond in the sum of ten percent (10%) of the total bid, but in no case in excess of \$20,000, payable to the Township of Lawrence as guarantee to furnish equipment/services for the bid.

The following bid documents must be included in bid package:

1. Non-Collusion Affidavit
2. Affirmative Action Statement
3. Bid Bond/Consent of Surety
4. Disclosure of Ownership Statement
5. Contractors Qualification Statement
6. Evidence of Public Works Contractor Registration
7. Sub-contractor List

Bidders must comply with the regulations of N.J.S.A. 10:5-31 et seq and N.J.A.C. 17:27. The Township of Lawrence reserves the right to accept or reject any and all bids for the above listed items in whole and/or part may waive informalities that the Township may, in its sole discretion, deem to be in the Township's best interest.

Bidders must also comply, if applicable, with P.L. 1999 c. 238, "The Public Works Contractor Registration Act". "Public Works" is defined as "the construction, demolition, alteration, repair or maintenance of a public building regularly open to and used by the general public or a public institution, and includes any subcontractor or lower tier subcontractor as defined herein, except that, for purposes of the Act, no pumping station, treatment plant or other facility associated with utility and environmental construction, reconstruction, demolition, alteration, repair or maintenance shall be regarded as a public building regularly open to and used by the general public or a public institution".
