

NOTICE OF BID

Township of Lawrence
County of Mercer

Notice is hereby given that sealed bids will be received and publicly opened and read at the Lawrence Township Municipal Building, Lower Conference Room, 2207 Lawrence Road, Lawrence Township NJ 08648 at 11:00 a.m. prevailing time on May 31, 2018 for the project known as **2018 ROAD IMPROVEMENT PROGRAM**.

The bid shall provide for approximately 84,500 sy of roadway milling and installation of 11,050 tons of HMA 9.5M64 surface course, striping and other associated work as set for in the specifications. Work will be performed on various roadways within the Township including but not limited to Albermarle Avenue; Allegheny Avenue; Ashleigh Drive; Chatsworth Court; Fairview Terrace; Fred Vereen Jr. Road; Hedge Row Court; Hendrickson Road; Heritage Way; Highfield Court; Indian Run; Jackie Drive; Landover Road; Lost Trail; Lawrence Avenue; Maplewood Avenue; Marilyn Court; Marvin Court; Morton Court; Northfield Court; Old Bridle Path; Old Denow Road; Princess Road; Province Line Road; Rossa Avenue; Roxboro Road; Stoney Creek Place; Stream Drive; Willow Road; and Woodmont Drive, and work within Township properties and parks. A detailed list is provided in the Appendix of the specifications. It is anticipated that a construction contract will be awarded on June 19, 2018. Construction shall commence on or about August 6, 2018 and shall be completed by October 5, 2018.

Signed bids shall be submitted in a sealed envelope, addressed to the Engineering Department with the name of the project printed on the face of the envelope. Bids shall be rejected if not submitted within time, date and place designated, and if not accompanied by a certified check, cashier's check, or bid bond in the sum of ten percent (10%) of the total bid, but in no case in excess of \$20,000, payable to the Township of Lawrence as guarantee to furnish equipment/services for the bid.

The following bid documents must be included in bid package:

1. Non-Collusion Affidavit
2. Affirmative Action Statement
3. Bid Bond/Consent of Surety
4. Disclosure of Ownership Statement
5. Contractors Qualification Statement
6. Evidence of Public Works Contractor Registration
7. Sub-contractor List

Bidders must comply with the regulations of N.J.S.A. 10:5-31 et seq and N.J.A.C. 17:27. The Township of Lawrence reserves the right to accept or reject any and all bids for the above listed items in whole and/or part may waive informalities that the Township may, in its sole discretion, deem to be in the Township's best interest.

Bidders must also comply, if applicable, with P.L. 1999 c. 238, "The Public Works Contractor Registration Act". "Public Works" is defined as "the construction, demolition, alteration, repair or maintenance of a public building regularly open to and used by the general public or a public institution, and includes any subcontractor or lower tier subcontractor as defined herein, except that, for purposes of the Act, no pumping station, treatment plant or other facility associated with utility and environmental construction, reconstruction, demolition, alteration, repair or maintenance shall be regarded as a public building regularly open to and used by the general public or a public institution".
