WHEREAS, in accordance with N.J.A.C. 5:50-14, a Certificate of Availability of Funds has been provided and the accounts to be charged are C-04-55-314-290 (\$131,900); C-04-55-298-265 (\$100,000); C-04-55-314-290 (\$23,997.99); C-04-55-102-296 (\$4,430.33); C-04-55-260-265 (\$94,315.60); C-04-55-286-255 (\$12,000) and a Grant (to be assigned) (\$365,950); and

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Lawrence, County of Mercer, State of New Jersey, that pursuant to the recommendations of the Municipal Engineer, the Mayor and Municipal Clerk are hereby authorized to execute a contract with McCauley Construction Co., Inc., 1340 State Route 36, Suite 2, Hazlet NJ 07730 in the amount of \$731,900.00, which includes the base bid and alternates 1 and 2; and

BE IT FURTHER RESOLVED that the Municipal Manager is hereby authorized to draft the necessary agreement, subject to the approval of the Municipal Attorney as to form and content thereof.

Manager's Report -

Mr. Krawczun submitted the Monthly Investment Report for August, September and October 2009.

Mr. Krawczun reported that the Administration is moving closer to the bidding process for the work project at the Twin Pines Airport Athletic Facility. And, so far, they have received approvals from the Mercer County Planning Board and Delaware Raritan Canal Commission. But, the DEP General Permits on wetlands are still pending.

Mr. Krawczun also reported that the Construction documents are complete with various rounds of provisions and they are now looking into the possibility of entering into a Co-op Agreement with Middlesex County which will permit Hopewell to purchase their turf or artificial surface for the installation on their fields. But, he advised there is a question pending before the Division of Local Government Services as to whether or not the contract will allow the site work to be included as part of that agreement.

Mr. Krawczun further advised that there is a meeting scheduled for next week to review the matter where the DLGS will rule or provide them with an opinion as to whether the contract can be utilized for that purpose and proceeded to discuss the next phase of the project as it relates to the bidding process for the site work.

Attorney's Report -

There was no Attorney's report.

Clerk's Report -

There was no Clerk's report.

Written Communications -

There was no written communications.

Old Business –

Mayor Mount distributed a booklet that was passed out at a League of Municipalities event honoring towns that have received their Sustainable New Jersey Certification and advised that Lawrence Township was one of the 32 towns who managed to get all the necessary paperwork in and achieved that certification which is a huge accomplishment for the Township, as there were 250 other towns registered who are still trying to achieve their certifications by exploring more sustainable practices within their communities.

Mayor Mounted further advised that the event was very well attended, and that the Township felt very honored to take part in such an event. However, this is only the beginning because the Sustainable New Jersey Certification is an ongoing process that the Green Team plans to carry on, so that they continue to improve the quality of life and the way things are done in Lawrence Township with respect sustainable practices. In closing, she thanked everybody who has taken part in helping to make Lawrence Township a sustainable "green" community.

New Business –

Mr. Puliti advised that the Holiday Tree Lighting is scheduled to take place at Town Hall on Sunday, December 13th at 6:00 p.m., and that The Presbyterian Church of Lawrenceville is tentatively planning to have a ceremony for the Revolutionary War Veterans on December 11th.

Mayor Mount further advised that the Lawrence Township band will have a Holiday Concert at the Senior Center on December 10th which is always a nice community event to attend.

There being no further business to come before this Council, the meeting adjourned.
